**Pavilion – Dave:** A call was made to determine if the builders would hold off, which they agreed to. Setbacks and zoning need to be looked into. Dave will look into permits, zoning, distance from grinder/well/road. There was a discussion of moving forward or waiting for price to come back down.

Motion: To move forward with building the building if the zoning & permits are in place
